‘Supply/Installation of CCTV Cameras, safety Grills, Razor wire and walkthrough Gates, etc’

Sealed tenders are invited from the reputed firms Islamabad/Rawalpindi and Registered with Sales Tax Department, having National Tax Number (NTN) for installation of CCTV Cameras at the Premises and other following job. Interested firms are requested to submit their technical (along with its brochures) and financial proposals in separate envelop for the following jobs/supply. 1. Installation of CCTV Cameras
2. Supply of walkthrough Gates and Razor wire 18 gauge
3. Installation of Exit Gates (Iron), two stairs and Safety Grills out side the windows.
4. Supply/installation of Fire Extinguishers and Smoke detectors
5. Construction of control room.
6. Up-grading the angles of boundary wall and Installation of Razor wire

Bids should reach the Institute up to August 06, 2015 the same shall be opened in the office of the Registrar PIDE same day at 11.00 a.m in the presence of vendors’

Terms and Conditions

1. The rates should be in round figure (in paisas are not acceptable) inclusive of **Sales Tax**.
2. The tenderers shall have to deposit @ Rs.3% of the total value of the bid as earnest money in the form of Pay Order/Demand Draft only (Cheques are not acceptable) in favour of Pakistan Institute of Development Economics, Islamabad along with quotation.
3. The earnest money will remain with the PIDE till the completion of the supply/job etc. It will be forfeited, if the firm fails to complete the task within specified period and try to supply/install the sub-standard material.
4. The vender must have established shop/ office at Islamabad / Rawalpindi, which will be inspected by the Institute’s authorized Officer (if deem necessary).
5. The quantity of cameras can be increased/ decreased.
6. The participating firms will have to give their G.S.T./NTN number /Profile and indicate the completion period of the task.
